### **DANGEROUS GOODS VEHICLE LICENCE**

#### **LICENCE DETAILS:**

Licence No: 5064489 Valid from 11/11/2014 to 11/11/2015

#### **VEHICLE DETAILS:**

The vehicle(s) listed in the attached schedule are covered by this licence to transport dangerous goods of the class shown.

#### **LICENCE CONDITIONS:**

1. A road vehicle that is transporting a load of dangerous goods under this licence must be covered by a policy of insurance or other form of indemnity for a sum not less than \$5,000,000 in respect of:
  - a) property damage, personal injury and other damage (excepting consequential economic loss) arising out of any fire, explosion, leakage or spillage of dangerous goods in, on or from the vehicle or a container transported on the vehicle; and
  - b) costs incurred by or on behalf of a government authority in a clean-up resulting from any event of the kind referred to in paragraph (a).
2. Any vehicle covered by this licence must comply with, and be used in accordance with, the relevant requirements of the NSW dangerous goods legislation and the Australian Dangerous Goods Code (ADG Code) at all times.
3. Every tank vehicle must be maintained so that it continues to comply with the ADG Code and the conditions of the tank design approval. Particular attention needs to be taken with respect to the vehicle ride height (for vehicle stability) and the ullage of each tank compartment.
4. The licensee must advise the Environment Protection Authority (EPA) immediately any vehicle covered by this licence is disposed of.
5. All **non-tanker vehicles** detailed on the schedule in this licence are approved for Dangerous Goods classes 2, 3, 4, 5, 6, 8, and 9.

Note: If any of the dangerous goods being transported are wastes, in addition to complying with provision of the NSW dangerous goods legislation, you need to comply with the provisions of the Protection of the Environment Operations Act and the Environmentally Hazardous Chemicals Act. Please contact EPA if you need more information.
